**ORDER**

In the current year's budget, an amount of Rs.320 lakhs has been allotted to Kerala State Centre for Advanced Printing and Training (C-apt), Thiruvananthapuram (C-apt) as Grant-in Aid under Plan Scheme under the head of account "2203-00-800-91-36-Grant-in Aid (plan)"

Accordingly, as per the Government Order, read as 1<sup>st</sup> paper above, Government have accorded Administrative Sanction for an amount of Rs.91,39,501/- for the completion of the construction of the extension work of Head Office complex of C-apt. Further, as per the Government Order, read as 2<sup>nd</sup> paper read above, Administrative Sanction was accorded for an amount of Rs.2,28,60,499/- for the purchase of machineries to C-apt.

Now, the Managing Director, C-apt has submitted the revised proposal curtailing the Plan expenditure for the year 2018-19 by 20% of the total budget outlay, as instructed in the G.O., read as 3rd paper above, in view of the recent flood havoc in Kerala.

Government have examined the proposal in detail and are pleased to accord revised Administrative Sanction by curtailing the budget outlay to an amount of Rs.2,56,00,000/- (Rupees Two crores and Fifty Six lakhs only) against the allotted budget outlay of Rs.3,20,00,000/- earmarked in the current year's budget under the Head of Account "2203-00-800-91-36-(Plan)" to Kerala State Centre for Advanced Printing and Training.


