ORDER

As per the proceedings read as 1st paper above, the Director, IHRD had accorded Administrative Sanction for Rs.9,94,600/- (Rupees Nine Lakh Ninety Four Thousand and Six Hundred only) for the Construction of building and external works in College of Applied Science, Kundara. M/s BSNL Civil wing was engaged as consultant for the construction work.

As per letter read as 2nd paper above, The Director, IHRD has requested Government to accord revised Administrative Sanction for an amount of Rs.12,65,931/- (Rupees Twelve Lakh Sixty Five Thousand Nine Hundred and Thirty One Only) for the work, due to the hike in the estimate. The Director has informed that the said work was executed as per the actual requirement at site and the enhancement was necessitated due to the shortage of provision in the original estimate.

Government have sought the report of the State Level

Expert Committee regarding the revised estimate. The Director of Technical Education as per letter read as 3rd paper has forwarded the report of the State Level Expert Committee recommending the revised Administration Sanction for the construction of building and external works in College of Applied Science, Kundara.

Government have examined the report in detail and are pleased to accord revised Administrative Sanction for Rs.12,65,931/- (Rupees Twelve Lakh Sixty Five Thousand Nine Hundred and Thirty One only) for the Construction of building and external works in the College of Applied Science, Kundara under the Institute of Human Resources Development.
