ORDER

1. The Hon.High Court, as per the Judgment read as 2nd paper above, directed Government to depute a Government nominee for the conduct of selection as requested by the petitioner in Ext P 3. It is also ordered that deputation of Government nominee will not preclude the right of the respondents to raise any sustainable objections as provided under law

2. The Manager, CMC Educational Society, as per the representation 1st cited has requested Government to provide its representative in the staff selection committee of that college for filling up of the vacancies of teaching staff. Government sought for the report of the Director of Collegiate Education regarding the accuracy and admissibility of the vacancies. Meanwhile the petitioner approached the Hon. Court with similar prayer and the Hon. Court directed to depute Government nominee.

3. Government have examined matter in detail and are hereby to nominate Sri. Antony T K, Additional Secretary to Government now on other duty as Registrar, Government Medical College, Palakkad as Government representative in the staff selection committee of colleges under CMC Educational Society (Vimala College & St. Mary's College, Thrissur) for filling up of the vacancies in English, Chemistry, Economics, Botany, Statistics, Sanskrit, Physical Education, Physics, Computer Science, History, Sociology, Social Work and Mathematics subject to the conditions that the appointment shall be done only in the sanctioned posts with 16 hours of workload.

4. The Director of Collegiate Education and the University shall ensure that the appointment will done only in the sanctioned posts with 16 hours of workload.

5. The Government representative shall furnish a report to Government within one week after the interview.

6. This order is issued in due compliance of the Judgment read as paper 2nd above.
