ORDER

As per the Government Order read as 1st to 6th paper above, Government have issued NOC for conducting self-financing/un-aided courses ranging from 1. B.A. Animation & Graphic Design 2. B.A.Multimedia 3. M.A. Cinema & Television 4. M.A.Animation 5. M.A.Multimedia 6. M.A.Graphic Design 7. M.A.Print & Electronic Journalism 8. B.A.Visual Arts 9. B.A. Audiography & Digital Editing 10. B.A.Visual Communication 11. B.A.Animation & Visual Effects in St.Joseph College of Communication, Kottayam from the academic year 2004-2005 to 2014-2015. However the Management has not applied for renewal of NOC later. Now, as per the application read as 7th paper above, Management of the Educational Institution has requested to renew/revalidate the NOC for the academic years upto 2018-19. The management has completed the formalities for the renewal of NOC in the revised pattern.

In the circumstances Government are pleased to renew the NOC issued for starting Self-Financing/Un aided courses of 1. B.A.Animation & Graphic

Design (40 seats) 2. B.A.Multimedia (40 seats) 3. M.A. Cinema & Television (20 seats) 4. M.A.Animation (12 seats) 5. M.A.Multimedia (12 seats) 6. M.A.Graphic Design (12 seats) 7. M.A.Print & Electronic Journalism (12 seats) 8. B.A.Visual Arts (40 seats) for the academic year from 2013-14 to 2018-19 and 9. B.A. Audiography & Digital Editing (40 seats) 10. B.A.Visual Communication (30 seats) 11. B.A.Animation & Visual Effects (30 seats) for the academic year from 2015-16 to 2018-19 subject to the following conditions.

1. The Educational Agency shall submit the documents to M.G. University to prove that the College has adequate infrastructure, human and physical to conduct the course as required by the Government.
2. The Educational Agency shall abide by the procedure of admission in the college as decided by the Government from time to time.
3. The Educational Agency shall set apart 50% of the seats of the course for being filled up by the Government or such authority determined by Government on the basis of merit and reservation principles followed by the Government and the remaining 50% filled by the Educational Agency on the basis of merit.
4. The Educational Agency shall collect only such fees as determined by the Government from time to time from the students admitted to the college for the course.
5. The Educational Agency shall institute adequate number of scholarships on merit cum means basis as determined by the Government from time to time to the students admitted to the course.
6. The Educational Agency shall appoint and fix the service conditions of the teachers and non teaching staff in the college for conducting the course as followed by Government in conducting similar courses.
7. The Educational Agency shall institute an appropriate governance structure that would ensure transparency, efficiency and social accountability in the Educational agency as determined by the Government from time to time.
8. The Educational Agency shall publish the details regarding the establishment and governance of Educational agency, admission, fees, courses, results, teaching and other staff, and any further information as required by the Government on the website of the Educational agency.
9. The Educational Agency shall run only courses approved by the

Government and the concerned University.

10. The Educational Agency shall enable the Government and its representatives to check, verify and monitor the compliance of the conditions mentioned above at any time the Government so decides.
11. The Educational Agency shall enter into an agreement with the affiliating University on the terms determined by the affiliating University in respect of all or any of the matters contained in this agreement.
12. In the event of breach of any of the conditions mentioned above by the educational agency, the Government is authorized to adjudicate the quantum of compensation which the Educational agency is liable to pay to the Government, if any, and upon such adjudication, the Educational Agency shall pay to Government the amount so fixed, failing which the amount of compensation adjudicated should be recoverable under the provision of Kerala Revenue Recovery Act, 1968, as if they were public revenue due on land.
13. The No Objection Certificate/ sanction granted shall be valid up to the end of the Academic year 2018-19 and renewable on the request of the Educational Agency and subject to the satisfactory compliance of the conditions specified herein.
14. In the event of the breach of any of the conditions mentioned above by the educational agency, the Government shall also be entitled to withdraw the sanction without formal notice to the Educational Agency.
15. The Educational Agency shall produce necessary documents for the continued affiliation from the University for the year 2018-19 before 31.01.2019 failing which the sanction issued will be treated as cancelled, w.e.f 01.02.2019 and the Government will not be responsible for any loss incurred by the institution and the institution shall be solely responsible for the losses thereof.
