ORDER

The Director of Collegiate Education, as per letter read 9th paper above had forwarded an application from Smt.Juvairiyya R.M, Assistant Professor in Statistics, Farook College, Kozhikode in order to sanction deputation for the period from 04-07-2017 to 03-07-2019 to undergo Ph.D. Course under Faculty Development Programme (FDP) of University Grants Commission.

On verification of the proposal, Government observed that if deputation is sanctioned from 04-07-2017 to 03-07-2019, the Teacher Fellow shall not complete the mandatory period of service for serving the institution double the period of deputation before retirement on superannuation. Hence Government as per letter dated, 19-04-2018 rejected the proposal for FIP deputation of Smt. Juvairiyya.R.M. Subsequently Director of Collegiate Education as per letter dated, 16-03-2019 has furnished a revised proposal in which the period of deputation is reduced to 20 months such that the Teacher Fellow complete the mandatory period of service before retirement.

As per the revised application submitted by Smt. Juvairiyya.R.M it is requested that the FIP deputation for a period from 04-07-2017 to 26-03-2019 so that mandatory provision for serving the institute for double the period of deputation can be fulfilled.


