ORDER

As per the letter read above, the Superintendent of Police, Railways, Kerala has informed that Anti human trafficking clubs were started in 5 colleges in Kochi since 2007, and the main objectives of formation of these clubs in colleges is to engage the youngsters in assisting Police to prevent Human Trafficking and to make the student community aware of the various types of Human Trafficking. Since the project has proved worthy of institutionalization in the field of prevention and detection of trafficking cases, functioning of Anti Human Trafficking Clubs have to be formalized. The Superintendent of Police, Railways, Kerala, as per letter read above has requested to take steps to issue necessary Government Orders for the successful establishment and smooth functioning of Anti Human Trafficking Clubs in all educational institutions in Kerala.

2. Government having examined the proposal in detail are pleased to order that Anti Human Trafficking Clubs shall be established in all Colleges in the State. As a primary step, the Director of Collegiate Education will take necessary steps to start Anti Human Trafficking Clubs in all Law Colleges and B.Ed Training Colleges in the State. The Principals of these Colleges shall nominate Nodal Officers in the institutions concerned for the smooth functioning of these Anti-Human Trafficking Clubs and to liaise with the State Nodal Officer, Anti-Human Trafficking Unit.


