ORDER

As per the Government Orders read 1st and 2nd above, the Deputy Director General of NCC of Brigadier Rank, who was the senior most Army Officer and the head of all NCC personnel in Kerala and Lakshadweep NCC Directorate, was delegated all the powers of Head of Department. In 2013, a post of Additional Director General in the Rank of Major General was created by the Integrated Headquarters of Ministry of Defence (Army) as Head of all NCC personnel in Kerala and Lakshadweep Directorate. As per the Government Order read as 4th paper above, Additional Director General, NCC was re-designated as the Head of NCC Department with effect from 19-03-2013 and all the administrative, financial and functional powers vested with the Deputy Director General, NCC as Head of Department has been delegated to the Additional Director General with effect from that date.

2. In para 5(v) of the Government Order read as 3rd paper above, issued in compliance with the direction of the Kerala Administrative Tribunal in its order dated 18-01-2017 in TA 6058/2012 filed by Kerala NCC Civilian Staff, it was directed to constitute an Empowered Committee for NCC Department as stipulated in GO (Ms) No. 27/90/P&ARD.

3. Government have examined the matter in detail and is pleased to constitute an Empowered Committee with the following officials for

NCC:


