O R D E R

In the CO's read above Government have issued orders implementing UGC Scheme in the State. The present rules are not applicable to those who opt for the UGC Scheme since they will be governed only by the new rules to be issued in accordance with the UGC Scheme. The issuance of the new rules/amendment of the existing rules to suit the UGC Scheme is under consideration of the Government and it will take some time for finalising the same. Pending finalisation and issue of new rules/amendments, Government are pleased to order the following clarifications.

(1) Placement to Lecturer Senior scale and Lecturer Selection grade/Reader will be done provisionally without convening Departmental promotion Committee or constituting Screening/Selection Committee till 31.3.1991 pending issue of rules under UGC Scheme.

(2) The other norms stipulated in the UGC Scheme for placement in paras 5.01 and 5.03 of the GO read as 3rd paper above will be fulfilled by the said incumbents within two years from the date of such placement.

(3) The same procedure will be followed till 31.3.91, also for appointments to the post of Principals, Deputy - Director of Collegiate Education and Additional Director of Collegiate Education, pending issue of new rules/amendment to existing rules.

(4) In future the placement to senior grade and Selection grade Lecturer/Reader will be done by the Director- of Collegiate Education and the placement to the post of Principals, Deputy Director of Collegiate Education, Additional - Director of Collegiate Education will be ordered by Government.

(5) In the case of those who come under the UGC Scheme on or before 17.6.1987 by way of promotions before that date, the case will not be referred to Selection/ Screening Committee, since the Government of India has stated that these cases need not be reopend.

(6) The placements will be purely provisional and subject to the decision of the Screening/Selection Committee to be constituted under the UGC Scheme.
