O R D E R

In the Government order read as 4th paper above,
Government have issued detailed orders regarding extension
of UGC Scheme to qualified teachers in Physical Education and
qualified Librarians working in Universities, Professional-
Colleges, Degree Colleges etc.

2. One of the demands of the University/College Librarian
Organisation is that the period of service in other categories
which has a salary scale equal to that of a Junior Lecturer
may be considered for placement in the higher scale.

3. The Anomaly Redressal Committee on the implementation
of UGC Scheme at the meeting held on 30.5.1991 has considered
the representations from University/College Librarians Organisations.
A Junior Lecturer is promoted as Lecturer after two
years of continuous service. In the UGC Scheme this period of
two years is considered for placement of college/university
teachers in the Lecturer senior scale and Lecturer Selection-
Grade. The committee is of opinion that a maximum period of 2
years of service in any category which has a salary scale equal
to or greater than that of Junior Lecturer may be considered for

placement in the higher scale. This is applicable to only to those Librarians who have come under the UGC Scheme. This recommendation is in conformity with the orders issued in the case of Lecturer counting their service as Junior Lecturers.

4. Government have examined the matter in detail and order that the Librarians who are eligible to come under the UGC Scheme as per G.O (MS) No. 87/91/H.Edn. dt. 9.4.91 ^a the maximum period of two years service ~~should be~~ in the Library Service, in posts equal to or higher than that of Junior Lecturer will be considered for placement in the higher scale.
